# **President's Message**

Dear Progress Club Members:

The last two years have been tough ones for us all, and for the Delmar Progress Club (DPC). COVID has led to isolation and social dysfunction. On top of the political turmoil our country has seen, the last few years



have been difficult. The DPC nonetheless continued to function, and evolved to meet the needs of the members, to the extent possible under the circumstances.

However, even before COVID, there were issues regarding lack of growth in membership and the lack of engagement with many members. I have deep concerns about our continued viability as a club. We desperately need to add new members in order to keep the club the vibrant organization it once was and can be again. We also need to rely on our current membership to keep the ship afloat.

I would like to note that the issue of membership is not just one facing the DPC, but rather is one facing many community organizations. In the book *Bowling Alone: The Collapse and Revival of American Community*, Robert D. Putnam discussed the reduction in all the forms of in-person social intercourse upon which Americans used to *found*, *educate*, *and enrich the fabric of their social lives*. (Sounds like the mission of the DPC, doesn't it?) Putnam noted the loss of membership in many existing civic organizations. We know he's right, and that this has been happening to organizations like the DPC.

We need to bring in new members, by reaching out to the community, by publicizing the good work we do, by becoming more involved in other community organizations, and by making sure that we are welcoming to those who join us for activities. So please help me with this. If you have a friend or neighbor who is retiring, or the kids are finally off to college, approach them and invite them to an event—to a bookgroup, to a community service project, or on one of our bi-monthly walks.

And if someone calls you and asks you for help with a project or to take on a leadership position, please say yes. If you want to share a leadership position, because you don't want to do it alone, just tell us. I understand that many have conflicting or other obligations, or are just not physically able to step up. But please try to do what you can.

I am also asking you all to think of new ways to bring in members, to reach out for ladies who might enjoy our club, and to pitch in the help us Spring Ahead! Please feel free to contact me, or our new Membership Chair, Debbie Gall, if you have ideas as to how we can increase membership. This is *our* club, and we all have a stake in keeping this wonderful organization financially stable and vibrant in its membership!

# **New York State Federation Honor Roll**

GFWC is not only a volunteer organization, but a group of women who are committed to annually honoring clubs and club members for their many volunteer efforts and contributions to their respective communities and to the partnerships of GFWC. Each year at our GFWC-NY convention, clubs and club women are presented with award certificates and ribbons in recognition of their volunteer efforts.

All clubs may submit names of their members to be placed on the NYS Honor Roll. Each club has a committee that decides who is to be nominated for this honor based on the clubwomen having made significant contributions to their respective clubs. At the state convention, each honoree is recognized with a

short speech about her accomplishments. As an added form of recognition, women who have been placed on the Honor Roll are eligible for Order of the Rose. Each honoree receives a certificate embellished with red roses, the flower of GFWC-NY. Fees required with submissions for these honors are deposited to the State Endowment Fund or the GFWC-NY Scholarship Fund.

In 2022, Debbie Gall was placed on the Honor Roll, and Joyce Demoly and Maryalice Svare, who were placed on the Honor Roll in 2021, received Order of the Rose certificates. Carolyn Bennett is currently the GFWC-NY Honor Roll and Order of the Rose Chairman.

# History of the Collect

Ever wondered about "The Collect" that we recite at many of our meetings? If so, you might be interested in a little background as to its inclusion at our club and district events and at all our federation meetings.

For many years, women's clubs in Canada, Britain, the United States and other countries have used a "prayer" at the opening or closing of their meetings and ceremonies. This prayer was written in 1904 by Mary Stewart, the principal of Longmont High School in Colorado, and has since been adopted as a club creed by women's clubs around the world.

Mary Stewart was born in 1876 in Ohio, but spent her childhood growing up in the Rockies. As the principal of Longmont High, she was described as "a little bundle of energy, dignity, and charm". It was during her tenure as principal that she wrote this collect. Mary Stewart worked for women's suffrage nationally. It was her belief that women working together for large ends had need for a special petition and meditation of their own.

The collect was officially adopted by the National Federation of Business and Professional Women's Clubs in 1920, and adopted by the General Federation of Women's Clubs (GFWC) a few years later. It was read into the printed records of the Congress of the United States at its closing session in 1949.

It is still recited today by women's clubs all over the world to instill a sense of unity and dedication to club goals and to one another. Something for all of us to keep in mind on the next occasion of its recitation!

# Standing Rules (Reviewed and Accepted May 2018)

# Section I

- There shall be kept a file of motions which affect the operation of the club. It will be maintained by the recording secretary and reviewed by the bylaws committee at least every four years, starting in 2016 and each Leap Year thereafter.
- 2. Keys for any file cabinet at Bethlehem Public Library will be held only by the president and first vice president (president-elect).
- 3. The president and vice president (president-elect) may be included as *ex-officio* members of a committee at the discretion of the committee chairwoman.
- 4. Club records and memorabilia will be reviewed every four years by a committee of past presidents chosen by the current president. This committee was activated in 1992 to function each Leap Year thereafter.
- 5. The president should announce the chairwoman of the Honor Roll Committee at the January Meeting.
- 6. The pin and gavel worn by the president will be passed to the incoming president and a new pin will be given to the retiring president.
- 7. It is the duty of the Nominating Committee to inform prospective officers, members of the Board of Directors, and the Nominating Committee of their duties, including the responsibility to attend all business meetings.
- 8. Starting in January of the even years, the first vice president (president-elect) may select committee chairwomen and group chairwomen, pending her election as president.
- 9. Each new president should update the incorporation papers as necessary.

# Standing Rules (continued)

- 10. It is important that resignations be submitted in writing to the Delmar Progress Club, PO Box 423, Delmar, NY 12054.
- 11. Club members are responsible for dinner, tea, luncheon or trip reservations unless canceled by the time specified by the committee. It is also important that payment for reservations reach the Reservation Chairwoman by the date designated.
- 12. As a courtesy, a current member should accompany a new member to the Holiday Tea in December and to the first meeting of her expressed interests.
- 13. Club members are automatically members of ALL interest groups and are cordially invited to attend meetings of interest. All members are urged to attend the general membership meetings.
- 14. The Incoming President upon election shall call a meeting of her new officers and chairwomen of standing committees and interest groups for the purpose of discussing respective duties and responsibilities of each, including those of program planning for the coming year.

# **Section II: Membership**

- 1. Individuals who have not paid their dues prior to the Fall Banquet are not eligible to attend the Fall Banquet. Members who are delinquent on October 1st may be dropped by action of the Board of Directors.
- 2. The membership form must be filled out by the applicant.
- 3. Long-time active members who no longer are able to participate in club activities may be retained as inactive members by vote of the board of directors.
- 4. Individuals who have been active members for 45 years may be considered for Life Membership. See Bylaws Article III, Section 2.
- 5. The membership chairwoman will maintain a file of all members indicating dates of admission, resignation or termination.

# **Section III: Study Groups and Committees**

- 1. No club member will be paid for giving or participating in a program; however, necessary supplies for the program may be covered.
- 2. Group and committee leaders shall be responsible for prudent fiscal expenditures within their budget and shall be required to submit a financial statement, together with an itemized bill and sales receipts, to the treasurer before reimbursement. A copy of the financial and activity reports from each chairwoman should be passed to her successor.
- 3. A copy of the financial and activity reports from each chairwoman should be passed to her successor.
- 4. The Community Service committee will expend its monies for Capital District needs.

#### Section IV: Finance

- 1. All monies requested in excess of a budget item must be presented in writing to the finance committee and voted by the Board of Directors. The treasurer cannot issue payments until such approval is given.
- 2. Delegates to General Federation of Women's Club meetings and conventions are responsible for expenses above that which is allowed in the budget.
- 3. Blackmore Scholarship Fund: In the event of dissolution of the Club, the remainder of this Fund will be transferred to the Bethlehem Public Library in accordance with the Will of the donor.
- 4. The Emergency Relief Fund shall be maintained to respond to local, national, and international emergencies and may be funded by fund-raisers or contributions.
